- from your use of our online services, whether to report any tenancy related issues, make an enquiry, a complaint or otherwise; from your arrangements to make payment to us (such as bank details, payment card numbers, employment details, benefit entitlement and any other income and expenditure related information).

We collect the following information about you:

- Bank statements for proof of earnings and income for all applications (tenants & Landlords that are companies)
- Proof of previous address (where required)
- Proof of employment and terms of such employment (where required)
- 3 month payslips
- Details of any criminal convictions (where required)
- Photo ID -passport/drivers licence
- Proof of Ownership (landlord only)
- Landlord Registration (landlords only)
- Company Registration (where required)
- Official documentation confirming Partnership, Trust or Company details
- Details of education institution you are attending & course details (student only)

We receive the following information from third parties:

- benefits information, including awards of Housing Benefit/Universal Credit
- payments made by you to us;
- complaints or other communications regarding behaviour or other alleged breaches of the terms of your contract with us, including information obtained from Police Scotland;
- reports as to the conduct or condition of your tenancy, including references from previous tenancies, and complaints of anti-social behaviour.

Why we need this information about you and how it will be used

We need your information and will use your information:

- To be able to go ahead with the application, with out this your application will not be considered.
- To confirm your identity
- To contact employers/pervious agents to confirm employment and for us to request references
- Statements to show income going into account relating to payslips provided
- Title deeds to prove ownership of property
- Company Registration number to confirm against Company House, check websites and reviews.
- to undertake and perform our obligations and duties to you in accordance with the terms of our contract with you;
- to enable us to supply you with the services and information which you have requested;
- to enable us to respond to your repair request, housing application and complaints made;
